Charges and Fees

All Doggy Daycare dogs must be picked up by 6pm or they will incur a Boarding charge and be boarded at the kennel for the evening.

All Boarding reservations must be held with a credit card. If you cancel your reservation within 48 hours of when it starts, you will be charged 50% of the entire planned stay. Fast Friends may charge some or all of a Boarding stay in advance during peak periods, such as Thanksgiving and Christmas.

Safety

Fast Friends makes every attempt to accommodate dogs with medical conditions in Doggy Daycare and Boarding. However, attendance at Doggy Daycare or Boarding is at Fast Friends' discretion and Fast Friends reserves the right to decide if Doggy Daycare or Boarding is not a good fit for a dog, based on medical condition or other factors, including but not limited to age, illness, presence of parasites, and behavior. Fast Friends reserves the right to turn away dogs at check-in or contact you to pick up your dog if it is determined that Doggy Daycare or Boarding is not an appropriate option for your dog. Your dog's acceptance into Doggy Daycare or Boarding is at the sole discretion of the staff.

If your dog is disruptive while at Doggy Daycare or Boarding, you may be called to pick up your dog. Your dog will not be able to return until the problem is resolved.

Risk and Responsibility

Your dog's attendance at Doggy Daycare or Boarding is not without risk. Every effort will be made by the staff to provide a safe environment for all dogs; however, Fast Friends is not responsible for any injury sustained by you or your dog while on the premises.

If your dog requires emergency medical attention, we will contact you immediately and transport your dog to your veterinarian or the after-hours, on-call veterinarian. You will be responsible for all charges incurred.

You are responsible for any damage or injury caused by your dog or the actions of your dog, including but not limited to: veterinary costs, hospital costs, and property damage. Vet charges due to injury to your dog or injury to another dog caused by your dog will be the responsibility of you and the owner of the other dog.

Fast Friends agrees to exercise due and reasonable care to board dog for the Owner. Fast Friends does not assume and shall not be held responsible for any liability with respect to the dog listed in this agreement, of any kind, character, or nature whatsoever, arising out of or from the boarding of this dog, or any damages which may accrue from any other cause whatsoever, including loss by fire, theft, running away, injury to persons, animals or property, unavoidable causes, or death or injury to any other animal caused by the within named dog during the term of this contract, whether this dog be on the premises of Fast Friends or not. Owner hereby agrees to be and is solely responsible for any and all acts of behavior of said dog at any time within the term and time for the contract. In no case shall Fast Friends be in any way liable or responsible.

All dogs must be leashed while on Fast Friends property, including travel between the car and the building. We do not allow the use of retractable leads.

Contract

This is a Contract between Fast Friends Doggy Daycare and Boarding (hereinafter called "Kennel") and the pet owner whose signature appears below (hereinafter called "Owner").

- 1. Owner agrees to pay the rate for Doggy Daycare or Boarding in effect on the date pet is checked into the kennel (as posted in office).
- 2. Owner further agrees to pay all costs and charges for special services requested, and all veterinary costs for the pet during the time said pet is in the care of Kennel.
- 3. Owner further agrees that the pet shall not leave Kennel until all charges are paid to Kennel by Owner.
- 4. By signing this Contract and leaving his pet with Kennel, Owner certifies to the accuracy of all information given about said pet that Kennel's liability to Owner or third party shall in no event exceed the lesser of the current chattel value of a pet of the same species or the sum of \$200 per animal boarded. Unless Owner files with Kennel within 30 days from the date the animal is removed from Kennel, a written demand for any claimed injury or damages resulting from the boarding of said dog under this contract, Owner shall and does hereby waive any and all rights which he may have against the Kennel for any liability arising under this contract, for damages, or otherwise. The Owner further agrees to be solely responsible for any and all acts or behavior of said pet while it is in the care of Kennel. Owner agrees not to claim any damages against Kennel of any nature whatsoever, either by way of contract, equity, negligence or otherwise, in excess of said sum.
- 5. Owner specifically represents that he or she is the sole owner of the pet, free and clear of all liens and encumbrances.
- 6. Owner specifically represents to Kennel that the pet has not been exposed to rabies, distemper, parvo virus or other contagious diseases or parasites within a thirty day period prior to attending Doggy Daycare or Boarding.
- 7. All charges incurred by Owner shall be payable upon drop-off of pet, or when billed by Kennel at the address listed on Contract. Kennel shall have, and is hereby granted, a lien on the pet for any and all unpaid charges resulting from boarding the pet at Kennel. If Owner does not pick up the pet within 15 calendar days after the day the pet was due to be picked up, the pet shall be deemed to be abandoned.
- 8. If the pet becomes ill or if the state of the pet's health otherwise requires professional attention, the Kennel, in its sole discretion, may engage the services of a veterinarian or administer medicine or give other requisite attention to the pet, and the expenses thereof shall be paid by Owner.
- 9. The Kennel reserves the right to treat your dog with flea/tick preventative if the Kennel finds the dog to be infested with fleas/ticks. The Owner shall incur the full cost of the flea/tick treatment.
- 10. This Contract contains the entire agreement between the parties. All terms and conditions of this Contract shall be binding on the heirs, administrators, personal representatives and assigns of Owner and Kennel.
- 11. Any controversy or claim arising out of or relating to this Contract, or the breach thereof, or as the result of any claim or controversy involving the alleged negligence by any party to this Contract, shall be settled by arbitration in accordance with the rules of the American Arbitration Association, and judgment upon the award rendered by an arbitrator may be entered in any Court having jurisdiction thereof. The arbitrator shall, as part of this award, determine an award to the prevailing party of the costs of such arbitration and reasonable attorney's fees of the prevailing party.
- 12. This agreement shall be governed by, construed, and enforced in accordance with the laws of the State of New Hampshire.
